- TWO STANDARD 5X3.25 DWT LOGOS/STICKERS (1 ON BOTH FRONT FENDERS OR BOTH SIDES OF HOOD)

## ALL ATV/SMALLER VEHICLES ARE REQUIRED TO PROMINENTLY DISPLAY AT LEAST:

- TWO STANDARD 5X3.25 LOGOS/DWT STICKERS (1 ON BOTH UPPER REAR FENDERS) AND
- TWO 3.25X2.15 SMALL DWT LOGOS/STICKERS (1 ON BOTH SIDES OF THE VEHICLE'S COWLING)
