- TWO LARGE 7.5X5 DWT LOGOS/STICKERS (1 ON BOTH UPPER REAR THIRD PORTIONS OF VEHICLE) AND

- TWO STANDARD 5X3.25 DWT LOGOS/STICKERS (1 ON BOTH FRONT FENDERS OR BOTH SIDES OF HOOD)

ALL ATV/SMALLER VEHICLES ARE REQUIRED TO PROMINENTLY DISPLAY AT LEAST:
